Little Ms. And Little Mr. Lee County Fair Rules & Regulations

1. Each contestant for the Little Ms. and Little Mr. Lee County Fair must be at least 6 years old and not more than 10 years old on July 1, 2022. The Little Ms. And Little Mr. do not go on to compete at the State Fair.
2. Each contestant must be a legal resident of Lee County, IA and/or attend a Lee County School.
3. If available, Little Ms. and Little Mr. can assist in handing out ribbons at the 4H Livestock shows and volunteer on Kid's Day.
4. The Ms. and Little Mr. Lee County Fair will be expected to represent the Lee County Fair at the Ft. Madison Rodeo Parade (September) and the Donnellson 4th of July Parade (the following year).
5. Contestants will be interviewed:
 - Name, Age, Town, and another simple question
(EXAMPLES: What is there favorite part about the fair or their favorite animal?)
6. Winners/Awards:
 - Names will be entered in a basket; **winner will be drawn at random** for each the Little Ms. and Little Mr.
 - Little Ms. will be awarded a sash and crown
 - Little Mr. will be awarded a sash
 - ALL contestants will receive a goody bag
7. ALL contestants are to be respectful at all times to all fair board members, other contestants and all patrons involved with the Lee County Fair. If an issue occurs, please go to the queen committee chair immediately.
8. Each Little Ms. And Little Mr. contestant is required to get her/his own sponsor or sponsors.
